- 6) THE STUDENT IS COMMITTED TO COMPLETING THE PROFESSIONAL PROGRAM FOLLOWING THE PROVISIONS OF THE ENROLLMENT AGREEMENT AND ALL PROGRAM REQUIREMENTS.
- 7) STUDENT HEREBY DECLARES THAT THEY MEET THE ADMISSIONS CRITERIA FOR THE PROFESSIONAL PROGRAM. IN CASE IT TURNS OUT THE STUDENT HAS BEEN ADMITTED TO THE PROGRAM BASED ON FALSE INFORMATION PROVIDED BY THE STUDENT, IT WILL BE CONSIDERED A SERIOUS BREACH OF THE PROVISIONS OF THE ENROLLMENT AGREEMENT.
- 8) STUDENT AGREES THAT EVENTUAL CHANGES TO ALL SPECIFIED CONTACT DATA (PARTICULARLY E-MAIL ADDRESS) SHALL BE NOTIFIED TO EDU EFFECTIVE BUSINESS SCHOOL WITHOUT DELAY AND DURING THE WHOLE PERIOD OF STUDENT'S PARTICIPATION IN THE PROGRAM (AND/OR DURING INTERRUPTION OF THE ENROLLMENT IN THE PROGRAM).
- 9) STUDENT HEREBY GRANTS PERMISSION TO THE EDU EFFECTIVE BUSINESS SCHOOL TO CAPTURE

12) THE STUDENT IS AWARE THAT ALL COMMUNICATION, STUDY AND COURSE MATERIALS, WRITTEN PAPERS, ETC. IS PROVIDED IN ENGLISH LANGUAGE OR ANOTHER LANGUAGE AS AGREED BY THE STUDENT AND EDU EFFECTIVE BUSINESS SCHOOL.

13) THIS EDU EFFECTIVE BUSINESS SCHOOL ENROLLMENT AGREEMENT IS CONCLUDED FOR A DEFINITE PERIOD OF 12 MONTHS (EFFECTIVE MBA, EFFECTIVE MSC., EFFECTIVE MPA, EFFECTIVE LL.M., MASTER OF BUSINESS ADMINISTRATION (MBA), MASTER OF SCIENCE (MSC.), MASTER OF PUBLIC ADMINISTRATION (MPA), MASTER OF LAWS (LL.M.)), OR OF 30 MONTHS (DOCTOR OF BUSINESS ADMINISTRATION (DBA)).

THE EDU EFFECTIVE BUSINESS SCHOOL ENROLLMENT AGREEMENT EXPIRES UPON COMPLETION OF THE PROGRAM BY THE STUDENT AND HAND-OVER OF THE CERTIFICATE OR BY RECALL FROM EDU EFFECTIVE BUSINESS SCHOOL OR THE STUDENT, OR AFTER A PERIOD OF 12, OR 30 MONTHS FROM THE DATE ON WHICH IT ENTERS INTO FORCE UNLESS THE PARTIES AGREE OTHERWISE.

14) CANCELLATION POLICY - EDU EFFECTIVE BUSINESS SCHOOL STUDENTS HAVE THE RIGHT TO CANCEL THEIR ENROLLMENT AGREEMENT AT ANY TIME AND ARE NOT CHARGED ANY FEES DURING THE FIRST FOURTEEN DAYS OF ENROLLMENT.

A LETTER OF CANCELLATION MUST BE EMAILED TO SKILLUP@EDUEFFECTIVE.ONLINE IN WRITTEN FORM. THE STUDENT'S LETTER OF CANCELLATION IS EFFECTIVE TEN DAYS AFTER THE EDU EFFECTIVE RECEIVES THE LETTER. THE STUDENT CAN CANCEL THE DECISION DURING THESE 10 DAYS AND CONTINUE STUDYING.

15) REFUND POLICY - STUDENTS WHO UNSUBSCRIBE OR LEAVE THE PROGRAM DO NOT HAVE TO PAY ANY FURTHER TUITION. STUDENTS WHO REMAIN IN THEIR PROGRAM BEYOND THE PROGRAM WITHDRAWAL DEADLINE ARE NOT ELIGIBLE FOR A REFUND OF THE TUITION. THE TUITION IS ONLY REFUNDABLE IN INSTANCES WHERE THE EDU EFFECTIVE BUSINESS SCHOOL HAS CANCELED A STUDENT'S PROGRAM/COURSE FOR OTHER REASONS THAN SERIOUS BREACH OF THE ENROLLMENT AGREEMENT TERM BY THE STUDENT.

STUDENTS WHO STAY OUT OF THE PROGRAM ARE NOT ELIGIBLE FOR A REFUND. THE TUITION IS REFUNDABLE ONLY IN CASES WHERE THE EDU EFFECTIVE BUSINESS SCHOOL CANCELED THE PROGRAM OR IN CASE THE STUDENT WISHES TO CANCEL THEIR STUDY WITHIN 14 DAYS OF REGISTERING; THE TOTAL COST THE STUDENT HAS PAID WILL BE REFUNDED IN SUCH CASES.

16) THE STUDENT IS RESPONSIBLE FOR PAYMENT OF THE FULL AMOUNT OF THE TUITION AND FEES CHARGED BY EDU EFFECTIVE BUSINESS SCHOOL.

17) THE STUDENT UNDERSTANDS THAT TUITION CHARGES ARE FOR THE RIGHT TO STUDY IN THE PROGRAM IN WHICH THEY ARE ENROLLED AND ARE IN NO WAY CONTINGENT UPON STUDENT'S SATISFACTORY PROGRESS, PERSONAL SATISFACTION, OR PLACEMENT UPON GRADUATION.

18) EDU EFFECTIVE BUSINESS SCHOOL IS ENTITLED TO TERMINATE THE STUDENT'S STUDY IF THE STUDENT FAILS TO MAKE TIMELY PAYMENTS DUE HEREUNDER OR IF THE STUDENT MATERIALLY VIOLATES ANY PROVISIONS OF THIS ENROLLMENT AGREEMENT. ANY SUCH

- 19) IN CASE THE PROGRAM FEE IS NOT SETTLED WITHIN THE AGREED PERIOD, EDU EFFECTIVE BUSINESS SCHOOL IS ENTITLED TO CHARGE INTEREST ON LATE PAYMENT OF 0.05 % FOR EACH DAY AND TO LIMIT ACCESS OF THE STUDENT TO THE STUDENT SYSTEM AND/OR OTHER COMPONENTS OF THE EDU EFFECTIVE BUSINESS SCHOOL PROGRAM UNTIL THE DUE FEE IS SETTLED.

- 23) THIS ENROLLMENT AGREEMENT SHALL BE CONSTRUED BY AND GOVERNED UNDER THE LAWS OF THE STATE OF HAWAII, US.
- 24) IF IT BECOMES NECESSARY FOR EDU EFFECTIVE BUSINESS SCHOOL TO INCUR ANY LEGAL EXPENSE AND COST TO ENFORCE THE TERMS OF THIS AGREEMENT, THEN EDU EFFECTIVE BUSINESS SCHOOL SHALL BE ENTITLED TO REASONABLE ATTORNEY'S FEES AND COSTS IN ADDITION TO ANY OTHER RELIEF TO WHICH EDU EFFECTIVE BUSINESS SCHOOL MAY BE ENTITLED.

- B) DOCTORAL SUPERVISOR – A LECTURER WHO SUPERVISES THE STUDENT DURING THE ENTIRE DOCTORAL PROGRAM IN TERMS OF COMPLETING A DISSERTATION THESIS WRITING AND OF THE ARTICLES WITHIN THE PUBLICATION ACTIVITY AND CONSULTS WITH THE STUDENT ON ALL SCHOLARLY QUESTIONS IN THE COURSE OF THE STUDIES. THE FORM OF COMMUNICATION WITH THE DOCTORAL SUPERVISOR IS ELECTRONIC.
- C) DOCTORAL PROGRAM – DOCTORAL PROFESSIONAL EDUCATIONAL PROGRAM (DBA); SUCCESSFUL GRADUATES EARN A COMPLETION CERTIFICATE AND A CZECH PROFESSIONAL DEGREE FROM EDU EFFECTIVE. THIS DOCUMENT ENTITLES GRADUATES TO UTILIZE A CZECH PROFESSIONAL (NON-ACADEMIC) DEGREE RECOGNIZED WITHIN THE CZECH BUSINESS FIELD.

ARTICLES PUBLISHED THREE YEARS BEFORE THE DATE OF ENROLLMENT IN THE DOCTORAL PROGRAM AT EDU EFFECTIVE ARE ALSO TAKEN INTO ACCOUNT.

SCHOLARLY ARTICLES PUBLISHED UP TO THREE YEARS BEFORE THE START OF THE DOCTORAL PROGRAM AT EDU EFFECTIVE ARE ALSO TAKEN INTO ACCOUNT. PUBLISHING ACTIVITY SHOULD BE RELATED TO THE STUDENT'S DISSERTATION AND/OR THE CHOSEN SPECIALIZATION. PUBLISHING ACTIVITY IS SUBJECT TO THE APPROVAL OF THE DOCTORAL SUPERVISOR. THE CRITERIA FOR PUBLICATION ARE SPECIFIED IN SEPARATE INSTRUCTIONS THAT ARE AVAILABLE FOR THE STUDENT.
- F) AT THE END OF THE DOCTORAL PROGRAM, THE STUDENT COMPLETES THE DISSERTATION THESIS AND DEFENDS IT IN FRONT OF THE THESIS COMMITTEE.
- G) THE DOCTORAL PROGRAM IS PROVIDED IN ENGLISH LANGUAGE OR IN A COMBINATION OF OTHER LANGUAGES AVAILABLE FOR THE DOCTORAL COURSES BASED ON THE PREVIOUS SELECTION OF THE STUDENT (COMMUNICATION AND THESIS).
- H) THE STUDENT OF THE DOCTORAL PROGRAM COMMUNICATES WITH LECTURERS OF EDU EFFECTIVE BY CHAT OR OTHER ELECTRONIC COMMUNICATION MEANS.
- I) THE STUDENT ACQUIRES AND PERFECTS THE KNOWLEDGE BY INDIVIDUAL STUDY OF RECOMMENDED READING, ELECTRONIC COURSE MATERIALS, BY MEANS OF ELECTRONIC CONSULTATIONS WITH LECTURERS ETC.
- J) IN THE COURSE OF THE DOCTORAL PROGRAM, THE STUDENT HAS THE OPPORTUNITY TO PARTICIPATE IN THE RECOMMENDED WEBINARS PROVIDED BY EDU EFFECTIVE.

 - D) THE PROPOSED TOPIC OF THE DISSERTATION THESIS AND THE CONTENT NEED TO BE APPROVED BY THE DOCTORAL SUPERVISOR.
 - E) THE DISSERTATION THESIS IS CONSULTED AND SUPERVISED IN THE COURSE OF THE WHOLE DOCTORAL PROGRAM BY THE DOCTORAL SUPERVISOR.
 - F) THE DISSERTATION THESIS IS PROCESSED AND SENT SOLELY IN ELECTRONIC FORM. IN CASE OF NONCOMPLIANCE WITH CRITERIA OR OTHER FAILINGS IN THE DISSERTATION THESIS, THE LECTURER IS ENTITLED TO RETURN THE DISSERTATION THESIS TO THE STUDENT FOR REVISION.
 - G) THE DOCTORAL SUPERVISOR IS OBLIGED TO SEND THE STUDENT FEEDBACK ON EVERY SUBMITTED CONCEPT OF A DISSERTATION THESIS OR EVALUATE EVERY FINALLY SUBMITTED DISSERTATION THESIS WITHIN APPROX. 14 BUSINESS DAYS OF THE DELIVERY OF THE GIVEN VERSION OF THE THESIS. AFTERWARDS, THE STUDENT IS INFORMED ABOUT THE EVALUATION OF THE DISSERTATION THESIS. AFTERWARDS, THE DISSERTATION THESIS IS SENT TO TWO OPPONENTS OF THE THESIS – SPECIALISTS IN THE FIELD – TO GIVE THE OPPONENTS EVALUATION. THE OPPONENTS ARE OBLIGED TO PROCESS THEM WITHIN 14 BUSINESS DAYS OF THE EVALUATION BY THE DOCTORAL SUPERVISOR. IN CASE THE STUDENT DOES NOT RECEIVE THE EVALUATION FROM EITHER THE DOCTORAL SUPERVISOR OR THE OPPONENTS, HE SHOULD INFORM THE EDU EFFECTIVE STUDY DEPARTMENT,

WHICH WILL INVESTIGATE THE CAUSE AND INFORM THE STUDENT REGARDING THE NEXT STEPS.

7) DEFENSE OF THE DISSERTATION THESIS

- A) THE DATE OF THE DEFENSE OF THE DISSERTATION THESIS IS DETERMINED BY EDU EFFECTIVE AND ITS ACADEMIC PARTNERS UPON INDIVIDUAL AGREEMENT BETWEEN THE SUPERVISOR AND THE STUDENT.
- B) THE DEFENSE OF THE DISSERTATION THESIS IS CONCLUDED IN FRONT OF THE THESIS COMMITTEE BY MEANS OF AN ONLINE VIDEO CONFERENCE CALL OR IN INDIVIDUAL CASES IN PERSON.
- C) THE DEFENSE OF THE DISSERTATION THESIS CAN BE COMPLETED ONLY AFTER THE SUCCESSFUL COMPLETION OF ALL COURSES OF THE DOCTORAL PROGRAM AND AFTER RECEIVING THE EVALUATION FORMS FROM THE DOCTORAL SUPERVISOR AND OPPONENTS.
- D) THE DEFENSE OF THE DISSERTATION THESIS LASTS APPROX. 1 HOUR.
- E) IN THE COURSE OF THE PREPARATION FOR THE DEFENSE OF THE DISSERTATION THESIS, THE STUDENT PREPARES A PRESENTATION OF 15 TO 30 SLIDES SUMMARIZING THE RESULTS OF THE THESIS AND THE ANSWERS TO THE LECTURERS' QUESTIONS. PRESENTATION IN ELECTRONIC FORM IS SENT IN ADVANCE TO THE DOCTORAL SUPERVISOR AND STUDY DEPARTMENT OF THE EDU EFFECTIVE AND ITS ACADEMIC PARTNERS. THE PRESENTATION IS PART OF THE ORAL DEFENSE OF THE DISSERTATION THESIS.
- F) IF THE STUDENT IS UNABLE TO TAKE PART IN THE DEFENSE DUE TO SERIOUS REASONS, THEY SHALL NOTIFY THE SUPERVISOR AND THE STUDY DEPARTMENT OF EDU EFFECTIVE AS SOON AS POSSIBLE AND SCHEDULE AN ALTERNATIVE MEETING FOR THE DEFENSE.
- G) IN CASE THE STUDENT DOES NOT DEFEND THE DISSERTATION THESIS IT IS POSSIBLE TO REPEAT THE DEFENSE ONE MORE TIME.
- H) THE CONDITION TO COMPLETE THE DOCTORAL PROGRAM IS TO DEFEND THE DISSERTATION THESIS.
